Most of the women who received this assistance were in the aftercare program (although some were in residence) which provides various kinds of support to previous residents for up to a year. Contact is continued through home visits, support group participation, phone calls, and mail. Except for the savings match payments, the payments noted were to third parties. Of the \$7,604 in transportation noted above, the 25 received specific assistance totaling \$3,105. The remaining \$4,499 was for cab fare, gas cards, and bus passes that were provided to a number of additional aftercare and in-house residents.

Expenses for postage and printing of invitations, program printing, costs of awards, if any, and other misc. expenses are not part of the FMV of the ticket price so become expenses not offset by revenue on line 8.
