Most of the women who received this assistance were in the aftercare program (although some were in residence) which provides various kinds of support to previous residents for up to a year. Contact is continued through home visits, support group participation, phone calls, and mail. Except for the savings match payments, the payments noted were to third parties. Of the \$4,116 in transportation noted above, the 9 received specific assistance totaling \$742. The remaining \$3,374 was for cab fare, gas cards, and bus passes that were provided to a number of additional aftercare and in-house residents.
